# A MESSAGE FROM THE GRAND MASTER

To say that this past year has been unusual would be a massive understatement. We opened the year with the most heavy and enduring snowfall, which meant sadly that we could not go ahead with the Grand Meeting of the Order on our usual January date. I would like to



apologise to those who were unable to join us later in the year but we have decided to revert to the January date in the hope that lightning [or in this case snow!] does not strike twice.

I was, however, very pleased that so many of you did make the revised date in May and we were able to admit three new Members as well as making a number of promotions. Whilst all the promotions were to recognise the generous support given by so many of you to the Order, I hope you will not mind if I mention two names: -

Margaret Gunnell was made a Dame Commander of St. Mark to thank her for the enormous amount of time and patience she has put in to ensuring that at last we have a reasonably secure flow of regalia when we need it. She has also redesigned the Order's cufflinks and lapel pins which are in my view much more tasteful than their predecessors, even though they can still be worn. David Haywood has made an outstanding contribution by producing our newsletter once again and sorting out a proper database of our membership – he was accordingly made a Knight Commander of St. Mark as a token of our appreciation.

I would also like to thank both Barry Uttley for his unfailing kindness and hard work as Grand Secretary and of course Julian Gunnell for so much help in arranging the Grand Meeting.



The recession this year has of course had its effect on all of us but nowhere has it been worse felt than among charities, who have seen their level of donations drop through the floor, whilst the needs of their clients grow. I was therefore very pleased that at the May meeting we were able to donate to Whizz-Kidz over £450. Still more is needed and I do hope that one or two of our members will make a personal donation



via our Grand Almoner, Ian Tough, to help some of the most disabled children in the U.K. achieve a better level of life.

There is a further lesson I feel to be learned from the economic problems we all face and that is that many of those whose main goal in life is material prosperity have little or nothing to show for their efforts and become what they term 'disillusioned' with their existence. ## **ANNUAL INVESTITURE AT PETERBOROUGH**

This year's Investiture had been postponed in January because of the bad weather, and was held on 8th May, again at Elindon, Peterborough. This year's event was again well attended, with nearly 50 in attendance. Details of postulants and promotions appear below.

The Grand Master and all those who attended were delighted to receive our honoured guest, Ashley Westpfel, Regional Fundraising Manager for Whizz-Kidz. As you will recall, Whizz-Kidz was chosen by our Grand Master as the charitable focus for the Order.

Addressing the assembly, Ashley described



how the recession had put great financial pressure on most charitable organisations, materially affecting their ability to deliver the much



needed help and care they exist to provide. Whizz-Kidz, the provider of mobility equipment and training for children with restricted mobility – services not provided by the NHS - had seen a decline in financial contributions as a result, although recent figures in 2010 were more encouraging. It was also clear that public expenditure constraints were likely to add to the problems of many of the families concerned.

Funds raised and contributions made at the AGM amounted to £452, which the Grand Master was delighted to present. You can read the subsequent letter of thanks on our website.

After the formalities had been completed, we retired into the adjoining dining area for lunch, where everybody had the chance to get to know each other or renew old acquaintances.

Following the splendid luncheon, The Grand Master opened the Annual General meeting. Items discussed were as follows:

### Appointment of Grand Prior and Grand Sub Prior

The Grand Master indicated that his wish was for the Order to eventually hold an annual investiture in a cathedral and that the appointment of a new Grand Prior was proving difficult. It was unanimously agreed that the Rev. Paul Butler should be appointed the Grand Sub Prior of the Order and Paul agreed to accept this appointment.

### Appointment of new Grand Registrar

The Grand Chancellor stated that the previous Grand Registrar, Chevalier Arnold Baker, had become inactive within the Order and that a replacement should be found. There were no volunteers at the meeting. (Subsequent to the Grand Council Meeting Chevalier David Haywood, who was unable to attend, volunteered to undertake the duties of Grand Registrar). I am very grateful to David for his offer and am confident that the Order's record of appointments, promotions and resignations are in good hands.

## Appointment of new post of Grand Almoner

Due to a continuing illness our Deputy Grand Marshal, Chevalier Ian Burnett, confirmed some time ago that he would be unable to continue in this post. He telephoned me prior to the Investiture to tender his apology for not being able to attend but volunteered his services for the post of Grand Almoner. Ian's kind offer has been accepted by the Grand Council; thank you Ian.

### **Presentation of Accounts**

The Grand Treasurer, Chevalier Ken Bamber, presented revised accounts for Y/E 30.6.2008 and also accounts for Y/E 30.6.2009. These were accepted by Grand Council.

### Grand Custodian of Insignia

Dame Margaret Gunnell stated that after some teething problems supplies from Central Regalia could now be relied on and that she had received over £600 from the sale of insignia and cuff-links etc. at this investiture.

### Consecration of a new Conclave in London

The Grand Master stated that he had given his consent for the formation of a new conclave which would meet in Putney to be called 'St. Thomas Becket – Martyr'. Chevalier Richard Thomas was working hard to create this new conclave which should be consecrated in the near future.

### **Future dates for Investitures**

After a general discussion the Grand Council conceded that our meetings on the third Saturday in January each year, despite the inclement weather, was still the most acceptable date to the majority of our members and it was agreed to revert back to this time of the year. [Our Grand Steward, Chevalier Julian Gunell, in his legendary efficient manner, has already booked the venue for next year – Saturday, 15th January 2011]. The Grand Master closed the Grand Council Meeting at 3.30pm.


